

## Global Health Hub Germany – NCDs Survey for the contribution to UN High-Level Meeting 2025

*Dear Members of the Global Health Hub Germany,*

*in September, the United Nations General Assembly will host the Fourth high-level meeting (UNHLM) on non-communicable diseases (NCDs), aiming to intensify global strategies and actions to combat NCDs. Given the growing global burden of these diseases and their impact on public health and social and economic systems, this meeting is expected to be a pivotal moment for shaping future international health initiatives and political priorities.*

*The Global Health Hub Germany (GHHG) seeks to gather insights and priorities from its members ahead of this important event. The purpose of this survey is to gain a clearer understanding of how German stakeholders from various sectors view the challenges and opportunities related to NCD prevention and control.*

*The results of this survey will provide valuable input for Germany's positioning and collaboration in the lead-up to and during the UNHLM on NCDs. The GHHG NCD Community will use the result to develop a policy paper with targeted recommendations on how Germany and the global community can more effectively contribute to reducing the burden of NCDs and strengthening global health systems.*
